- c. Balances on weddings are due 90 days prior the event, school balls are due 30 days prior to the event, and social events are due 7 days prior to the event;
- d. Deposit payment is accepted by Cash, Credit Card or EFT transfer;

- i. Showtime Limousines reserve the right to terminate any and all services due to unruly, intoxicated or abusive passengers without a refund. If the driver determines that the passenger is under the influence of prohibited substances the service will be terminated without refund;
- j. The hiring customer will be held responsible for the conduct of all the passengers in the vehicle at all times;
- k. Showtime Limousines operate a "NO SMOKING" policy within all their vehicles. Should this condition be ignored the driver is authorised to terminate the hire agreement and a refund will not be offered under any circumstances;
- l. Any damage or breakages caused during the hire will be charged to the hiring customer, including fabric damage, spill, soiling. A \$400 cleaning fee will apply to any soiling. Broken glasses are charged at \$4 per glass;
